Education & Mobilization

In Senegal, rural parents send children to boarding schools in distant cities to receive religious education. Fake teachers often enslave the children instead in forced begging gangs. We helped parents build a village school so children can learn safely at home.

Rescue, Rehabilitation, Reintegration

When they first arrived at the rescue shelter, you could see in their eyes that these children had endured the unimaginable as child fishing slaves. "We were tied with ropes and beaten, with no food for the day," they said. "We slept on the bare floor with no blankets."

Now, after support from doctors, teachers and social workers, these Ghanaian children can dream once again. Dziwonya wants to become a police officer, Esenam wants to become a nurse, Christopher wants to be a teacher.

With freedom, it's possible.

Protecting Women and Girls

We empower women by providing education about women's rights, self-help groups, vocational training, and formal schooling.

Safeguarding Children

We teach parents and children about children's rights and establish systems of rescue, shelter and rehabilitation.

Building Socioeconomic Security

We increase access to education, health care, vocational training and savings clubs to improve physical and social well-being.

Strengthening Community Advocacy

We help community leaders advocate for better police protection and increased social services to reduce vulnerability.

Trafficking's Footprint

Our baseline project research in Ghana uncovered more than 600 cases of child trafficking in 34 communities. The report recommended

increasing the number of victims receiving comprehensive traumainformed care, ensuring at-risk families can provide for basic needs, and increasing public awareness of child trafficking. **MORE...**

2018 Freedom from Slavery Forum

More than 80 global anti-slavery leaders mapped a future of coordination and cooperation in Thailand at the 2018 Freedom from Slavery Forum, managed by Free the Slaves. As signatories of the Bangkok Statement of Principles, delegates set standards for action by governments, businesses, civil society, and labor organizations.



Alliance to End Slavery & Trafficking

A major 2018 advocacy victory: Congress adopted ATEST coalition recommendations to strengthen the U.S. Trafficking Victims Protection Act. Free the Slaves serves as ATEST secretariat and co-chair. The renewed trafficking act improves protections for victims and tightens standards for country rankings in the annual Trafficking in Persons Report.

Alliance 8.7

Free the Slaves serves on the Global Coordinating Group of Alliance 8.7, acting as a voice for civil society in the movement to achieve United Nations Sustainable Development Goal 8.7, the end of modern slavery, human trafficking and child labor.





Community Liberation Initiative

Our Community Liberation Initiative trains frontline activists and international development field workers to safeguard communities from slavery. In 2018 we integrated our strategies into the literacy programs of READ Nepal, educating 2,500 people about their rights. In Ghana, we beta tested our new manual on rescues and survivor care.
